**INSTRUCTIONS FOR FILLING OUT THIS BALLOT**

1. After reviewing the enclosed materials, mark the appropriate box next to your choice on the ballot by completely filling in the box like this: ■. Mark either yes or no.
2. Sign your name in the designated area on the ballot. **Your ballot cannot be counted unless it is signed.** A ballot will not be accepted nor tabulated if: 1) it does not have an original signature; 2) is unsigned; 3) lacks an identifiable "yes" or "no" vote as indicated by filling in the box; or 4) appears to have been tampered with or otherwise deemed invalid based upon its appearance or method of delivery.
3. Place the ballot into the return envelope.
4. Seal the return envelope and mail. No postage is necessary if mailed in the United States.
5. All ballots **must** be received prior to the close of the Public Hearing scheduled for **9:00 am on August 31, 2022, at the Tulare County Ag Commissioner's Office located at 4437 South Laspina Street, Tulare, California 93274**, or they will not be counted.
6. Ballots may be hand-delivered to the Tulare Irrigation District office during normal business hours (8:00 am to 5:00 pm) prior to the Public Hearing at the following address:

Ballots may also be hand-delivered to the Board of Directors during the Public Hearing which will be held on Wednesday, August 31, 2022 at 9:00 a.m. The hearing will take place at the **Tulare County Ag Commissioner's Office located at 4437 South Laspina Street, Tulare, California 93274** to consider the new assessment.
8. If you lose or destroy your ballot, you may request a replacement ballot by calling MK Elections at 209-259-6740 by August 23, 2022 at 3:00 p.m. A replacement ballot may also be obtained at the Public Hearing.
9. Ballot return envelopes will not be opened until the conclusion of the public hearing and votes will be weighted according to the proportional financial obligation on the affected property. Additionally, if you wish you may change your vote at any time prior to the conclusion of the public hearing on this matter.
